(2) The United States Government will prohibit seal killing for the Government. same period in the same part of Behring Sea and on the shores and islands thereof, the property of the United States (in excess of 7,500 to be taken on the islands for the subsistence and care of the natives) and will promptly use its best efforts to ensure the observance of this

prohibition by United States citizens and vessels.

(3) Every vessel or person offending against this prohibition in the said waters of Behring Sea outside of the ordinary territorial limits of the United States, may be seized and detained by the naval or other duly commissioned officers of either of the High Contracting Parties, but they shall be handed over as soon as practicable to the authorities of the nation to which they respectively belong, who shall alone have jurisdiction to try the offense and impose the penalties for the same. The witnesses and proofs necessary to establish the offense shall also be sent with them.

(4) In order to facilitate such proper inquiries as Her Majesty's Gov- Inquiries by Her ernment may desire to make, with a view to the presentation of the Majesty's Government. case of that Government before arbitrators, and in expectation that an agreement for arbitration may be arrived at, it is agreed that suitable persons designated by Great Britain will be permitted at any time, upon application, to visit or to remain upon the seal islands during the

present sealing season for that purpose.

And whereas it is also provided by said section that "the existence of either of the conditions aforesaid shall be determined by the President of the United States by proclamation made from time to time as the purposes of this Act may require:"

And whereas satisfactory official assurances have been given that in Belgium, France, Great Britain and the British possessions, and Switzerland, the law permits to citizens of the United States the benefit of copyright on substantially the same basis as to the citizens of those countries:

Copyright benefits extended to citizens of Belgium, France, Great Britain, and Switzerland.

Now, therefore, I, BENJAMIN HARRISON, President of the United States of America, do declare and proclaim that the first of the conditions specified in section 13 of the act of March 3, 1891, is now fulfilled in respect to the citizens or subjects of Belgium, France, Great Britain, and Switzerland.

## A PROCLAMATION.

July 31, 1891.

Preamble. Vol. 26, p. 612.

Whereas, pursuant to Section 3 of the Act of Congress appro-October 1, 1890, entitled "An Act to reduce the revenue and eq duties on imports, and for other purposes," the Secretary of S. the United States of America communicated to the Government of S the action of the Congress of the United States of America, with a vie to secure reciprocal trade, in declaring the articles enumerated in Section 3, to wit, sugars, molasses, coffee and hides, to be exempt fiduty upon their importation into the United States of America;

And whereas the Envoy Extraordinary and Minister Plenipotentic of Spain at Washington has communicated to the Secretary of St. the fact that, in reciprocity and compensation for the admission in the United States of America free of all duty of the articles enumers in Section 3 of said Act, the Government of Spain will, by due legal actment, and as a provisional measure, admit, from and after Septe ber 1, 1891, into all the established ports of entry of the Spanish islan of Cuba and Porto Rico, the articles or merchandise named in the lowing Transitory Schedule, on the terms stated therein, provided the rangement with Spain. the same be the product or manufacture of the United States and p. ceed directly from the ports of said States:
